## 2<sup>nd</sup> ANSE Professional Conference

### *Value dilemmas as a challenge in the practice and concepts of supervision and coaching*

May 7 until May 8, 2004 Leiden, the Netherlands

#### **Introduction**

Value dilemmas play more and more an important role, overt and/or hidden in the practice of supervision and coaching, for supervisees, organisations and for supervisors. How conscious of these dilemmas are we? How to handle these dilemmas on the various levels: within the supervision with the supervisees; in the relationship with the commissioner; as individual supervisor; as professional association of supervisors?

#### **Content of the conference**

During this conference experts and participants will concentrate themselves in a co-creational process, on questions such as:

- Which value dilemmas confront supervisors and coaches?
- Which temptations, challenges and limitations can be identified:  
Are supervisors strongly influenced in practicing their job by the laws of the market, or can they represent professional values in a competent way?
- Which connection is there with national and organisational cultures?
- What is the connection with the specific context and field in which supervision is carried out?
- Which help concepts of supervision could offer supervisors in handling these dilemmas?
- Which perspectives are important to be defined by ANSE and her member associations?

#### **Programme design**

Participants have every opportunity to exchange working experience with European colleagues. The central focus of the conference is the daily practice of the supervisor/ coach.

After opening, the conference starts with a warming up in small groups of an international setting. Then three smaller groups will be joined together for further discussion in **case-focused workshops**; participants discuss cases from supervision practice in various countries and fields, and draw consequences for own supervisory behaviour. Participants in these workshops will rejoin on several moments during the conference.

On the second day of the conference experts in supervision and coaching from 8 different countries and with various expertise and backgrounds will offer **theme workshops**. They tackle the aspects of values, norms, methods and their way of approaching supervision and coaching. All participants enrol 2 different workshops.

Moreover, an inspiring lecture will be held in a plenary session each day.

#### **Conference language and translation facilities**

The conference language is English and German. Simultaneous interpretation will be provided during the plenary sessions. In the small group sessions and workshops collegial interpretation in other languages than indicated will be offered as far as possible.

## Information on keynote speakers

Key note speakers of this 2<sup>nd</sup> ANSE Professional Conference 2004 are:

- **Prof. Dr. Zygmunt Bauman** (Leeds, GB), is known throughout the world by his hundreds of publications. He is described variously as one of the twentieth century's great social theorists and the world's foremost sociologist of post modernity. He awarded the Amalfi European Prize in 1990 and the Adorno Prize in 1998. It is difficult to think of higher honours being bestowed on a sociologist, in this case of European and indeed world standing.
- **Prof. Dr. Peter Heintel** (Klagenfurt, A), is, besides his professorship on philosophy and group dynamics at the University of Klagenfurt, a guest lecturer at several academic institutes in Austria, Germany and Switzerland. Above these he is working as an organisational consultant in numerous enterprises in these countries.
